Code Update (Version 007.001.007)

A SEDAR code update is scheduled for December 2, 2002. It's size is approximately 1.2 MB and should take approximately 15 minutes to download using a 28.8K modem.

You are encouraged to obtain the code update as soon as possible on or after December 2, 2002 by following these procedures:

- 1. Start the SEDAR program;
- 2. Select File menu: and
- 3. Select Receive items from SEDAR server.

This method will make sure that the application is updated and ready for your use before you actually have to perform any business functions.

This code update will bring the SEDAR client application up to Version 007.001.007.

Please be patient and **allow the download to finish before proceeding**. Once the code update has been downloaded, close the SEDAR program and follow the instructions below to execute the code update:

- 1. Click the Start button located at the bottom left corner of the screen;
- 2. Select Programs; and
- 3. Select SEDAR and then select Code Update.

Summary of Code Update Changes

1. New document type

We have added the Notice/consent forms under FOI legislation (ON) document type to the filing type CPC Prospectus (CDNX) under the category of filer Other Issuers/Securities Offerings/General so that this can be separately identified in SEDAR.

2. New local policy statement

BC Policy Statement 12-603 replaced BC Local Policy Statement 3-35 on May 30, 2001. This option has been added to the Local Policy Statement Elections field located on the Issuer Cover Page screen. Filers should not use BC Local Policy Statement 3-35.

3. Modifications to the SEDAR software

(a) Filers will no longer be restricted to the 8 character DOS naming convention for SEDAR file folders and documents. SEDAR will now follow the Windows 32 bit naming convention allowing a maximum of 32

characters in the file name and an additional 102 characters for the file path i.e. (C:\SEDARDOCUMENTS\MYLAWYER\PROJECTS\\ANNUALFINANCIALS\4123456\ISSUERN OVEMBER2002.pdf). This change affects both the Attach File and Attach Formal Correspondence screens.

- (b) It is now possible to simultaneously view the fee description and the amount columns located in the Add/Modify Fees screen.
- (c) Page breaks have been changed so Project Lists and Document Lists within the Search Filings module will now print a full page of data when appropriate.

4. Commission fee description changes

Department of Government Services and Lands Government of Newfoundland and Labrador: CDS would like to inform subscribers of a new fee to be paid through SEDAR for the above recipient agency. The new fee description is as follows:

"Each Form 45-102 filed shall be accompanied by a fee of \$50.00"

Please note this new fee description is effective immediately and SEDAR will be updated at a later date to reflect this change. A subsequent subscriber notice will advise on the scheduled code update.

NOTE: For any filing fees now payable, filers are asked to enter the fee on the following line currently in SEDAR:

"Every Form 19 filed (\$50)"
